CLASSIFICATION IS VALID IN TERMS OF USE FOLLOWING PRODUCT

« PANGUA-FIRE - Peuplier »:

The classification is valid for the following end use applications:

For thicknesses from 5 mm to less than 10 mm:

- monting with mechanical fixation (nails, screws.) directly on the substrate,
- without air gap on a class A2-s1,d0 substrate or better with minimal density of 525 kg/m3 and minimal thickness of 12 mm (standard plaster board type).

For thicknesses from 10 mm to less than 18 mm:

- mounting with mechanical fixation (nails, screws.) on D-s2,d0 wood structure or better,
- without air gap on a class A2-s1,d0 substrate or better with minimal density of 525 kg/m3 and minimal thickness of 12 mm (standard plaster board type),
- the mounting is without aur gap or with closed or open air gap of any thickness. For thicknesses from 18 mm to 40 mm:
- monting with mechanical fixation (nails, screws.) on D-s2,d0 wood structure or better,
- on a class D-s2,d0 substrate or better with minimal density of 510 kg/m3 and minimal thickness of 10 mm (standard particle board type), with or without protective rain screen rated E or better,
- the mounting is without air gap or with closed or open air gap of any thickness, according to table 8 of standard EN 13986.
