QUALITY POLICY

As for quality, the General Management of PANGUANETA SpA pays great attention to the reliability of its products and services to achieve maximum customer satisfaction, since customers are the only ones who can decide the success of the organization through their choices.

The operational principles of the organization resulting from this approach are:

- Meeting the customers' expectations and needs;
- Improving and strengthening its position in the business sector;

All the staff members are aware of the importance that quality plays in every sector, and therefore are asked and motivated to follow the rules contained in the documents relating to the Integrated Management System.

SUSTAINABLE FORESTRY MANAGEMENT

For sustainable forestry management, PANGUANETA SpA undertakes to adopt a Chain Of Custody management system in compliance with FSC® and PEFC standards which rely on the non-use of wood falling within these categories:

- Wood harvested from forest areas where the traditional or civil rights of indigenous peoples, local communities or other parties involved are infringed and their entitlement to the ownership and use of the is rejected.
- Wood harvested from protected forests or areas of high conservation importance, or failing to contribute to the safeguard, conservation or improvement of biodiversity in terms of landscape, ecosystem, species or genetics.
- Wood harvested from those areas where forests are unable to produce woody and non-woody forest products, and sustainable forest services or harvest volumes exceed a threshold that can be kept in the long term.
- Wood harvested from non-FSC® certified forest areas where high conservation values are threatened;
- Wood harvested from genetically modified trees (GMOs);
- Failure to comply with the forest management regulations;
- Failure to grant the health, work and safety of personnel as well as to follow the ILO Declaration on fundamental principles and rights at work (1998);
- Natural forests that have been turned into plantations or non-forest areas;
- Wood harvested from areas involved in armed conflicts.



ENVIRONMENT AND ENERGY POLICY

For the environment and energy, PANGUANETA SpA believes that the safeguard of the environment as well as the reduction of energy consumption and greenhouse gases are core values to be constantly pursued, with the awareness of the growing attention paid by the community to environmental and sustainable development issues.

Therefore, PANGUANETA SpA is mindful of the fact that its activities, products or services may affect the natural ecological balance, regards the protection of the environment and the reduction of energy consumption as its strategic objectives to be considered for the performance of all its activities.

PANGUANETA SpA has adopted an Environmental and Energy Management System, according to UNI EN ISO 14001 and UNI CEI EN ISO 50001, whose primary goals are:

1. Compliance and constant application of legislative requirements;
